ENROLLMENT AGREEMENT

By submitting a registration form, you are agreeing to the following

CAMPER

Carmans River Adventure Day Camp and the Parents or Guardian signing below who are financially responsible for the Camper hereby enter into this Enrollment Agreement in reference to the Camp's offer of enrollment for the Camp season of 2021 subject to the terms and conditions listed below.

***TUITION/FINANCIAL OBLIGATIONS:** Rates are as listed in our 2021 Summer Day Camp rate schedule posted in our brochure and online. Add-on days are billed at the existing day rate at the time of extension.

Pre-Registration Rates must be paid in full by specific dates- **Rate Saver** 3/1/2021. **Early Bird Rates** 4/15/2021 **Regular Rates** 4/16/2021

Daily Rates- any camp days added after the start of camp will be subject to a daily rate and must be paid in full at the time at camp attendance.

The Camp reserves the right to cancel the trails and Roman if for payment is not received prior to the start of camp

***CHANGE FEES-**The fee of \$30.00 will be billed for any charges to the original registration form for any reason, after 6/1/18. This fee cannot be waived under any circumstances. * **LATE FEE** Any outstanding balances as of July 1, 2021, will be assessed a 5% late fee.

***SECURITY FOR NON-PAYMENT**

Camper families with outstanding account balances from the previous Summer will not be eligible for enrollment. A late fee of \$50.00 per month as well as an 18% finance charge will be charged to any invoice that remains unpaid as of September 1, 2021. As of October 1, 2021 all open balances will be forwarded to collections and all attorney fees, filing fees or collection fees will become the responsibility of the delinquent party.

***MISCELLANEOUS PROVISIONS**

1. Carmans River Adventure Day Camp reserves the right to remove a Camper at any time if his or her behavior is determined to the safety and well-being of any other individual in the camp environment.
2. I understand that completed medical form and emergency contact form must be on the file in the Camp office no less than two weeks before Camp begins. If this is not received, the Camp can refuse a camper's attendance to camp that any refund towards lost days.
3. There will be no refunds or make-up days for non-consecutive missed days at camp due to illness, family matters, or injury. If a camper is absent consecutively or three days or more or due to medical reasons only, credit towards these days for next years in Rome it will be made for each day missed, provided a physician's note is submitted appropriately evidencing medical reasons for absences.
4. Photography and videography taken at Carmans River Adventure Day Camp may be used for promotional purposes; names of the campers will never be published.
5. If sunscreen is not applied by the family, Carmans River Adventure Day Camp reserves the right to apply sunscreen to all campers.
6. In order to ensure the safety of all campers, early dismissal must take place by 2:30 pm or you must wait for regular dismissal time of 3:30 pm.
7. Buddy request must be reciprocated and the requested but he must be in the same age group.
8. Return checks and declined credit cards will be subject to a \$30.00 charge.

This Enrollment Agreement may be canceled in writing prior to May 1, 2021. All withdrawals/deletions made prior to May 1 2021, will be subject to a \$150.00 per week cancellation fee. These rules shall apply regardless of the reason for cancellation.

Upon receipt of the complete and accurate registration, the camper will be deemed enrolled.

Waiver of Release of Liability

By enrolling my child and signing this document, I agree to and understand the following in its entirety:

In consideration of my child allowed to participate in any and all activities at Carmans River Adventure Day Camp, the undersigned acknowledges, appreciates and agrees that:

There is a possible risk of injury from activities involved in this program and while particular rules and personal discipline may reduce the risk, the risk of injury does exist.

I knowingly and fully assume any and all such risks are which are inherent in the activities in which I or my child engaged, both known and unknown, for myself and my child, even if arising out of negligence of the releases and am participating or allowing my child to participate in all activities voluntarily and am willfully undertaking and assuming all risks.

I willingly agree to have my child comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove my child from participation and bring to the attention to the nearest camp official immediately.

I, for myself, on behalf of my heirs, assigns, personal representatives and next of kin, hereby release and hold harmless Carmans River Adventure Day Camp. Their officers, officials, agents and or employees, and other participants,(releases) with respect to any and all injury, disability, death or loss to damage to person or property whether arising from the negligence of the release or otherwise.

For the general welfare of all campers, the Camp reserves the unrestricted right to dismiss any camper who's conduct or influence in the opinion of our directors is contrary to the best interest of the campers and the camp.

The camp is not responsible for any "lost" or "stolen" personal property that campers may take to camp.

This contract constitutes the full understanding of the parties hereto and no change, modifications or waiver and of the terms shall be effective unless in writing and signed by BOTH parties

I/we have read this release of liability and fully understand its terms. I/we understand that there are certain risks inherent in the activities engaged and I/we assume said risks. I/we have given up substantial rights by signing this release and sign it would voluntarily and free from coercion. Should any portion of this agreement determined unlawful, all other portion shall remain in force and effect.
